Zion United Church of Christ Annual Meeting of the Congregation January 29, 2023, 10:00 AM

The annual meeting of Zion United Church of Christ was called to order by President David Braun on Sunday, January 29, 2023, following the 9:00 am worship service. Head usher Ron Weyl counted 46 members in attendance, which was more than required to meet the quorum requirement.

Pastor Rosemary led the opening prayer.

Eileen Wells made a motion to approve the minutes from the 2022 annual meeting. Mark Pinney seconded the motion, and it was passed unanimously.

Treasurer Dustin Kahle reviewed the Treasurer's report. A couple factors that were brought to light in the review – Guide One, our church insurance offered an on-line program that is called "Safe Church program policy" which David Braun participated in. This will save the church \$1,100 in insurance premium. Our investment funds in United Church Funds are closely watched by the Investment committee, with 60/40, stocks/bonds usually balance out, but have both dropped.

Sue Felmlee made a motion to accept the Treasurer's report as written. Mark Pinney seconded it and it passed unanimously.

President David Braun thanked the Audit committee of Bob Palmer and Gary Thelemann for reviewing the 2022 financial reports.

President Braun asked if there were any questions or comments about any of the other printed reports. He commented that the Council is intending to reactivate committees that have been dormant during Covid.

There are two Council members retiring this year and there are four nominations for four seats on the Zion Church Council. The slate of candidates includes Lynn Reinhardt (2^{nd}) term for a three-year term of the Elders. Bob Braun for (1st) three-year term of the Deacons. Bill Sinell (1st) and Mark Pinney (2nd) term of the Trustees. President Braun asked for any nominations from the floor. With no other nominations from the floor, Steve Pioske made a motion to cast a unanimous vote for the slate of candidates as presented. John Pioske seconded the motion and it passed unanimously.

Dustin Kahle, a Deacon and also Treasurer presented the 2023 Budget. There were several factors that made the budget "best estimate of the future" more challenging. As now we do not have a Christian Education Director, or a Visitation Pastor, and what our call for a new Pastor will be. It was noted that the Elders have been working on the church membership roles and the per-capita dues to the Conference will be less. Eileen Wells made a motion to accept the proposed budget, as presented. Mark Pinney seconded the motion and it passed unanimously.

There was no Old Business.

Under New Business President Braun explained how the Search Committee was formed. At the direction of the MN Conference the Chair of the committee is chosen first, and then the committee members.

Bob Braun thanked Pastor Rosemary for her leadership and all she has done for our church. Pr. Rosemary thanked the congregation. Betty Jo Braun thanked the Council members that were completing their terms- Cindy Braun and Monty Braun.

With no other business, President Braun asked Pastor Rosemary to close with prayer, and the meeting was adjourned.

Zion United Church of Christ **Special Congregational Meeting** September 10, 2023

The Special Congregational Meeting of Zion United Church of Christ was called to order on Sunday, September 10, 2023, by President David Braun at 9:58 a.m., following the 9:00 a.m. worship service. There were 83 members in attendance. President David Braun declared a quorum present: 5% of 12/31/22 membership (285) = 15.

John Pioske led the opening prayer.

President David Braun noted that the meeting was being held for a congregational vote to extend the call to Pastor Janet Crissinger as the next minister of Zion United Church of Christ.

President David Braun welcomed Pastor Janet Crissinger and thanked her for leading the worship service and for her consideration of becoming the next called minister of Zion Church.

Chairman Ryan Thelemann from the Search Committee made a motion for the Congregation to vote to approve Pastor Janet Crissinger as the next called minister of Zion Church as approved by the Church Council at the August 27, 2023, meeting. Steve Kley seconded the motion, and the motion was unanimously approved.

Ryan Thelemann presented the Congregation with Pastor Janet Crissinger and noted that Pastor Janet Crissinger has a broad range of experience in her past. There were no questions for Pastor Janet Crissinger from the Congregation.

Pastor Janet Crissinger was excused for the congregational vote.

Ballots were handed out to all active members of the Congregation that were present. The appointed tellers to tally the vote totals were: Lauralie Axtell, Dustin Kahle, Bill Sinell, and Tanya Dvorak. 83 total ballots were cast. The appointed tellers were excused to tally the votes.

Pastor Janet Crissinger was recalled and the vote totals were announced. Pastor Janet Crissinger was approved as the next called minister of Zion United Church of Christ with vote totals of 81 yes votes and 2 no votes.

Thank you to the Search Committee for their hard work in this process: Chairman Ryan Thelemann, Bob Braun, Elaine Cronk, Keith Lammers, John Pioske, Barb Mostaghimi, Victoria Manske, and for Pastor Rosemary Rocha's early guidance in the process.

President David Braun made a motion to adjourn. Pastor Janet Crissinger led the Congregation in a closing prayer.

2023 ANNUAL REPORT of Interim Pastor Rev. Rosemary Rocha for January 1 through September 17, 2023

"We can do no great things, only small things with great love." Mother Teresa

As we entered 2023, I continued as full-time Interim. In addition to the "usual" aspects of that ministry, I worked with the Pastoral Search Committee, as they continued the important job of completing the Church Profile for the pastoral search. Once completed and the MN Conference of the UCC approved the profile, my work with that intelligent and hard-working group was done. The remainder of my time was spent on the "usual" pastoral work.

- Worship, Preaching and Sacraments. Between January and my final Sunday, September 17, I planned, led and preached at most Sunday services, officiated at Communion, and the Reception of New Members. I officiated at two weddings, two Baptisms and three funerals. Many thanks to Pastor Bob Broeder for leading worship and preaching on several Sundays. United Theological Seminarian Heather Rushfeldt led worship, preached and held a class after worship on January 22. On February 12, the Rev. Kelly Gallagher, Associate Conference Minister of the MN Conference UCC led worship with me, delivered the sermon, helped install the Search Committee and had a conversation after worship with those gathered. Worship was deeply blessed by the faith and commitment of Brian Braun who did all the tech work for all worship services and, many times, caught my glitches while they could still be corrected! Worship was also blessed by our Adult Choir and Director Chase Burkhardt who we sadly said farewell to in May as he moved in new directions. Zion has been blessed for a long time with exceptional musicians: Mary Trimbo, Betty Jo Braun and Art and Barb Straub.
- Confirmation. It was a privilege to lead and confirm an amazing group of seven youth. In addition to semi-monthly classes, each youth interviewed two church members on their faith and wrote personal faith statements. They assisted me in administering ashes on Ash Wednesday and participated in the Maundy Thursday Service of Tenebrae. I offered a challenge grant to any or all of the confirmands: Take on some outreach ministry of their own design following Confirmation. Rose Wagner and Jack Thelemann accepted it and in August had a successful "Christmas in August" dinner raising funds and gifts for the Mankato Salvation Army.
- Meetings: Met monthly with Council and Council President to plan agenda and discuss church business; Met regularly with Christian Education and Ruth Circle. Worked with Ruth Circle to plan a catered "Mother/Daughter" brunch in July. Occasionally met with Altar Committee and Visiting Friends. Met with Ecumenical clergy to plan and help lead Vacation Bible School.
- Administration: Had regular church office hours; staff meetings with Church Administrator Diane Frauendienst, Choir Director Chase Burkhardt and Custodian Craig Hinks. Following Craig's resignation, together with the Council President and Chair of Trustees we first hired Lisa and Nick Ross and following their resignation hired Tonya and Dustin Kahle for that position.
- Wrote weekly letters for e-news and monthly letters for Zion Herald, proofed bulletins, newsletters, correspondence. Basically, did whatever needed doing in terms of church administration – but – all that I was able to do was supported and made possible by two very important people: Diane

Frauendienst, Zions' Administrative Assistant and Bookkeeper. I greatly appreciate who she is, her deep faith, and her commitment and love of Zion and its people. David Braun, Council President who not only supported me and the church but was also able to find diplomatic ways to suggest I rethink or reconsider something!

- Late August the Search Committee was able to do what some thought might be impossible find a great candidate to be the Pastor of Zion: the Rev. Jan Crissinger. That meant that our time together was ending, but that is what we knew from the start. Your farewell to me still makes my heart sing, the love, the blessings, the gifts.
- Thank you so much for not only allowing me to be a part of your life, but for being a part of mine. Reading the newsletters since September, it looks like life is going well and I continue to hold you all and Pastor Jan in my thoughts and prayers.
- So, remember those words of Mother Teresa let us, with joy continue to do small things, every day, with great love! I know you can....

We welcomed Bob Braun and Bill Sinell to the Council and said thank you to Monty Braun and Cindy Braun for their service. You and I have been very fortunate to be served by a Council who diligently and faithfully approached all the tasks of the past year with genuine good humor and respect for each other. Also in January, in our quest to call a new pastor, we were blessed with a capable and dedicated group of individuals serving as a Search Committee. They were Ryan Thelemann, John Pioske, Elaine Cronk, Bob Braun, Victoria Manske, Keith Lammers, and Barb Mostighimi, and they began the process with information assembled by the Transition Team.

Throughout the year the condition of programs and building maintenance were improved-ridding the building of outdated and unnecessary items and updating records of membership and committees. We also searched for and employed other new staff. Over the course of the year three different families of custodians have served the church. We continue to seek to hire a choir director and boiler operator. In all cases the change in personnel was amicable-just different or better employment opportunities. We have welcomed VINE ministries into the building, hosting a monthly care-givers support group. We continue to sustain the Prayer Project that has every member of the church prayed for daily by another member of Zion and revitalized the Christian Education program.

In all of this we were guided by and collaborated with our Interim, Pastor Rosemary Rocha. The Council and congregation were blessed with her leadership and creativity and are very thankful for her presence. In September when her time with us was over, she and others were totally impressed with the gracious way you expressed your thanks for her ministry with and among us. Pastor Jan Crissinger accepted our call this fall and has already blessed us with amazing talents in preaching and music. We feel God's hand in this new relationship.

One constant over the past couple of years has been office administrator and bookkeeper, Diane Frauendienst. She has been a huge help to me, the Council, and other staff as the go-to person amidst all the changes. For all of us I offer her a super-sized thank you!

Finally, I wish to commend you for your stewardship. When the Trustees identified problems with our 60-year-old building you stepped up to fund repairs. Financing repairs and maintaining programs will likely continue to be challenging. But I do have confidence that this community serves a purpose in your life of faith and that generous gifts of time and resources will make all things possible.

Trustees' Report

2023 has again been a busy year for the trustees. Our facility continues to show its age requiring an increasing level of maintenance.

The trustees performed an annual inspection early in the year and items of concern were identified for observation or repair. Items of note from the trustees this year:

- The backsplash in the kitchen was repaired by Lyle Felmlee and Dave Weyl. We offer a special thank you to Lyle and Dave for volunteering their time and expertise.
- With the help of many members the excess pews were sold and removed from the undercroft.
- Bids were taken to replace the stair treads to the Social Hall and the Classrooms. At over \$8000 it was decided to not proceed at this time and add it to the church wish list.
- A water heater was repaired.
- The anti-backflow valve for the boiler was fixed and relocated for easier annual inspection.
- The trustees over saw repeated repairs to our flat roofs. Areas included were:
 - 1) The overflow area.
 - 2) The entry into the women's' bathroom and above the stairs going up to the classrooms.
 - 3) The north entry into the sanctuary by the usher's stand. Unfortunately, this leak has still not been located in spite of repeated attempts to do so by a roofing company.
- The trustee's received a bid to install automatic door openers for the North and South outer doors and the North inner doors. At \$15,000 the bid was viewed as too expensive, and we are continuing to investigate less expensive openers.
- We continue to look for a new boiler operator. We wish to offer our deepest gratitude to Glenn Kroehler for many years of service as our boiler operator.
- Many lights inside and outside the church were replaced including the lights in the church sign.

For 2024, the trustees will continue to work on projects we did not complete this year. They include painting the back splash in the kitchen, finding a boiler operator, investigating lower cost automatic door openers, finding our roof leak and ways to reduce our energy usage through more efficient lighting, solar energy and upgrading our heating system.

Thank you to all members for their continual support of all the projects completed this past year. With your continued support physically and financially we will be able to continue as good stewards of this wonderful facility.

Last school year, all grade levels participated in church school on Wednesday evenings. There were three groups including the confirmation class, grades 6 and 7, and pre-K through 5th. This proved to be a bit difficult to teach a lesson geared toward a wide variety of age ranges. The children were divided into new groups according to age for the 2023-2024 school year. We began the year with the pre-K through 2nd grade having church school Sunday mornings after the Children's message during church service. This was a nice way to allow the children to attend church service and have a shortened church school lesson to keep them busy. The challenge with this approach was that families with children in various age groups were split up with different days of the week and arrival/departure times for church school since the 3rd through 5th grade group met on Wednesdays from 6:00-7:00pm and the preconfirmation group met Wednesday evenings as well. We will adjust our approach this winter semester by having all age groups attend church school on Wednesday evenings from 5:30-7:30pm. This will hopefully be more convenient for families with multiple children and allow the children to attend classes geared more according to their age. We will also continue with music time and a light meal every Wednesday evening for the children.

Zion participated in Vacation Bible School this past summer with the assistance of Pastor Rosemary, and we are starting to plan for summer of 2024. Vacation Bible School will be hosted at Zion this coming summer. Planning has already begun and includes Pastor Jan along with members from the United Methodist and Lutheran churches as well.

In October, the 3rd through 5th grade class received Bibles during church service to take home and use during their classes. The Bibles were presented by their teachers. There have been other activities for the children this year, thanks to the planning of Pastor Jan. The confirmation class was able to travel to Chaska and participate in Feed My Starving Children. A wonderful Christmas program (thanks again to the talented Pastor Jan) was held this December where the children sang songs and performed the Nativity scene. The children did a beautiful job singing and the confirmation students did a fantastic job narrating the program. There will be several other activities planned for the children this coming semester including a trip to the cities to visit a synagogue and a mosque on February 16th.

We are always looking for new ideas to expand enrollment and make our church school program the best it can be. If you are interested in volunteering your talents during church school or being a part of the committee, please reach out to any of the committee members or Pastor Jan. We look forward to a great New Year!

Music Director

What does the Music Director do? I create and operate the PowerPoint for the Church services that puts the order of service, litanies, hymns, prayers, scriptures, and other parts of the service up on the screen. Zion UCC Housing Fund (360813)

Fund consists of sale of Parsonage sold for \$59,596; any profit above this can be spent for pastor's housing

Zion UCC Scholarship Fund

All dollars are available; the purpose is to provide dollars to Zion's young adults successfully attending a college or trade school. December 2023 - \$750 withdrawn to cover scholarships paid in 2023.

Zion UCC Improvement & Benevolence Fund (360816)

Principal can be used only for improvement or benevolence of Zion church; no minimum balance requirement.

Zion UCC Horrisberger Family Endowment Fund (360817)

The principal of these funds is viewed as held in perpetuity; however, the interest can be used in support and maintenance of worship, educational, mission and religious activities and community services of the Church, together with the upkeep of all properties belonging to the Church. Funds cannot be withdrawn in amounts that would reduce the principal below \$349,340.00. December 2023 - \$26,000 withdrawn to purchase CD #8709092430. \$50,000 12-month at 5%.

Zion UCC Brenke Fund (360820)

A gift from the Brenke Estate; no minimum balance requirement. December 2023 - \$11,100 withdrawn to purchase CD #8709092430, \$50,000 12-month at 5%, \$25,000 withdrawn to purchase CD #8709092429 \$25,000 4-month at 5%.

Zion UCC Brandt Fund (360821)

A gift from the Don Brandt estate; has a limit of only one-third (1/3) can be spent each year for the first three years of the gift (starting 2017). December 2023 - \$2977.63 withdrawn to purchase CD #8709092430. \$50,000 12-month at 5%.
